The Tender should reach to the undersigned on or before Dt.29.10.2018 at 12.00 Noon and the same will be opened on date 30.10.2018 at 11.00 AM in the officer chamber of the CDM & PHO, Boudh in the presence of the bidders or their authorized representatives. The authority reserves full rights to accept or reject any or all tenders without assigning any reason thereof.

**Tender Cost**

The bidders have to submit Tender paper cost fee of Rs. 500/- (Non-refundable) by way of separate Bank Draft drawn in favor of ZSS NPCB, Boudh payable at Boudh.

**E.M.D**

i. The tenderer is required to submit the earnest money deposit amounting to Rs. 5000/- (rupees Five thousand) only in shape of bank draft from any nationalized bank in favor of ZSS NPCB, Boudh payable at Boudh.

ii. The E.M.D. of the unsuccessful bidder will be returned only after finalization of the tender.

iii. The E.M.D. will be forfeited if the successful bidder will refuse to supply the indented items.

**Terms & Conditions**


1. The tender should be properly sealed with insignia and be superscribed as " TENDER FOR SUPPLY OF FREE SPECTACLES FOR SCHOOL CHILDREN AND PRESBYOPIC GLASSES FOR PATIENTS".
2. Attested Copies of GST return certificate of last quarter or last month & GST Registration no. must be attached with the tenders.
3. Specification of Spectacles (a) Frame – Acetate (different colour) (b) Lenses – White. Simple frame is required to be submitted along with sample with the tender paper for selection.
4. The Spectacles provided by the bidder will be free of air bubble spectacles, waves & irregular shape & carry three months warranty for repair & replacement for any manufacturing fitting defects (e.g. Loose hinges) free of cost.
5. The successful bidder must supply the required spectacles within 15 days of receipt of the order. The Optical centers are expected to keep enough stocks of the frame ( of different sizes & colours) and the lenses to ensure timely supply of the spectacles to the children.
6. If the above specifications are not adhered to or the child has been provided wrong lenses, as found later by the ophthalmic Asst. the bidder will not be entitled to receive any payment for such spectacles. He is to provide free replacement, if payment was already received. If this happens too often the Dept. can terminate the contract with the bidder even before the stipulated expiry of its period.
7. The approved rate will be valid for a period of one year from the date of approval.
8. The cost of the spectacles should be within the Govt. approved price including all taxes.
