The bidders has to deposit 1% of the estimated cost put to tender through payment gateway of designated bank as per office memorandum of works department, Government of Odisha No. 17254 Dtd. 05.12.2017.


***The bidders are requested to participate well before the scheduled date to avoid delay in RTGS time consumption, if any.**

AVAILABILITY AND RECEIPT OF TENDER PAPERS

1. The availability of bid document through online & receipt of the Bid document through online is from **02.11.2018 to 15.11.2018** during office hour.
2. A bidder can submit only one tender paper for a particular work and submission of more than one tender paper by a bidder for a particular tender will liable for rejection of all such tender papers. Adjustment of EMD shall not be entertained in any circumstances.
3. **DATE, TIME & PLACE OF OPENING OF THE TENDER PAPERS :**
The tender shall be opened **17.11.2018** at **11.00 A.M** in the office of the undersigned in the presence of the tenders or their authorized representatives. If the office happens to be closed on the last date of sale and receipt of the tender as specified, the tenders will be sold and received and opened on the next working day at the same time and venue. The bidders or authorized agents are to be present during the opening of the tender as per time and venue with all relevant original documents for verification.
4. Bid documents consisting of plans, specifications, the schedule of quantities and the set of terms and conditions of contract and other necessary documents can be seen in the office of the undersigned during office hours every

day except on Sundays and public holidays and local holidays till last date of sale and receipt of tender paper. Interested bidders may obtain further information at the same address

5. Additional performance Security shall be obtained from the successful bidder when the bid amount is less than estimated cost put to tender. In such an event, only the successful bidder who has quoted less bid price/rates than the estimated cost put to tender shall have to furnish the exact amount of differential cost i.e. estimated cost put to tender minus the quoted amount as "Additional Performance Security (APS) in shape of NSC/Term Deposit Receipt pledged in favour of the Divisional Officer from any Nationalised / Scheduled Bank in India / Post office within seven days of issue of letter of acceptance (LoA) by the divisional officer (by email) to the successful bidder otherwise the bid of the successful bidder shall be cancelled and the earnest money deposit / bid security shall be forfeited. Further, proceeding for black listing shall be initiated against the bidder (vide office memorandum No – 14459 / W Dtd. 20.09.2018 of works department. Government of Odisha)".
6. Quality control tests as per specification for all items of the work executed will be taken in nearby Government Quality Control Laboratories of Minor / Medium / Major Irrigation Organization. It is binding on successful bidder to extend all necessary support in getting the tests done till completion of the work in all respects.
7. No Engineer of Gazetted rank or other Gazetted officer employed in Engineering or Administrative Department of the State Government is allowed to work as a contractor for a period of two years after his retirement from Government service without due permission of the Government.
8. The bidder shall have to furnish No relation certificate along with the bid documents to the effect that no officer of the Department to the rank of Assistant Engineer or above is related to him.
9. All bidders are required to submit the details of quarry for procurement while submitting bids.
10. If L1 bidder does not turn up for agreement after finalization of tender, then he shall be debarred in participating in bidding for three years and action will be taken to blacklist the contractor. In that case the L2 bidder if fulfills all other criteria would be called for drawing agreement for execution of work subject to the condition that L2 bidder negotiates at par with the rate quoted by the L1 bidder, otherwise tender will be cancelled.
11. If rate quoted by a bidder is less than 15% of the tendered amount, then such a bid shall be rejected and tender shall be finalized basing on merits of rest of bids. But if more than one bid is quoted at 14.99% (Decimals up to two numbers will be taken for all practical purposes) less than the estimated cost, the tender accepting authority will finalize the tender through a transparent lottery system where all bidders/ their authorized representatives, the concerned Executive Engineer and DAO will remain present.
12. Before acceptance of tender, the successful bidder will be required to submit a work programme and milestone basing on the financial achievement so as to complete the work within the stipulated time and incase failure on the part of the agency to achieve the milestone, liquidated damage will be imposed.
13. Office Memorandum File No. 07556900042013 (PtII)-7885/W dated 23.07.2013 will be treated as part of DTCN and instruction to bidder.
14. Other details can be seen from the bidding document.
15. The works are very urgent in nature and in case non drawing of the agreement within 07 (seven) days from date of finalization of tender, the officer inviting tender will have the right to cancel the tender with forfeiture of E.M.D. It is time bound work.
16. All the bidders have to abide by the budget provision of Government of Odisha.
17. Successful bidder after drawl of agreement should obey the FRBM Act Odisha strictly.
18. All the bidders must have to mention their Mobile no and e-mail ID at the time of uploading the bid documents for smooth communication. Bidder will be intimated electronically regarding the tender evaluation and if required for the transparent lottery system.
19. The single tender received in the first call shall be cancelled without opening the bid. "In case of cancellation of single tender which have not been evaluated, the tender paper cost deposited by the concern bidder shall be refunded to him / her". Vide works department office memorandum No. 07556900142018-12925/W Dtd. 23.08.2018.
20. The successful bidder have to abide by the Goods & Service Taxes rules amended time to time as issued by Govt of Odisha.
21. The authority reserves the right to reject any or all the bids without assigning any reason thereof.
22. The Authority will not be held responsible for any technical snag or network failure during online bidding
