



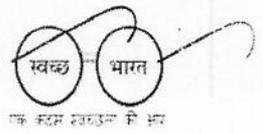

Quotation call Notice for engagement of Hired Vehicle

Sealed quotations/tenders are invited from interested reputed Travel agencies or private individual for providing 1 no. of BOLERO/SCORPIO (Full body multi utility vehicle) AC driven vehicles having sitting capacity not more than ten including driver, which shall conform to the terms and conditions (Annexure-II) for official use in RWS&S Division, Boudh on monthly rent basis:

1. The vehicle must be in Road Worthy, shall not be more than 3 years old from the date of initial registration and must have valid Registration Certificate, Insurance Certificate, Fitness Certificate, Valid Contract Carriage Permit, proof of up to date tax payment etc. which are mandatory for plying of vehicle.
2. The driver of the vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficient experienced in driving transport passenger vehicle.
3. The driver should be well behaved, gentle and obedient in nature.
4. A sum of Rs. 5,000.00 shall be deposited by the intending bidders in shape of Account Payee Bank Draft in favour of Executive Engineer, RWS&S Division, Boudh and submitted along with the tender as security deposit. After completion of tender process, the amount will be refunded to unsuccessful bidders.
5. The vehicle will run as per the requirement of project work in the district of Boudh for Swachha Bharat Mission (G).
6. The monthly rate hire charges are quoted separately in the general bid information (Excluding fuel and lubricants).
7. The vehicle must achieve a fuel efficiency of 10 KMs per liter.
8. The details of the make and year of manufacture of the vehicle, Registration No., Mileage (KMs covered by per liter) and name of the driver with Driving License No. and period validity should be specifically provided in the general bid information to be furnished with the quotation / Tender (Annexure-III)
9. The Quotation completed in all respect should reach the DWSM, Boudh office on or before 12.08.2019 by 12.00 noon and shall be opened on the same day at 01.00 PM in presence of the bidders or their authorized representatives. The authority reserves the rights to accept or cancel any or all tenders without assigning any reasons thereof.
10. The application form of quotation / tender containing General Bid information & Term and conditions for Hiring of Vehicles etc. will be available with the DWSM, Boudh office from 30.07.2019 to 11.08.2019 or can be downloaded from district Website www.boudh.nic.in from date 01.08.2019 to date 11.08.2019.
11. Service Tax GST will be reimbursed separately over and above the hire charges.

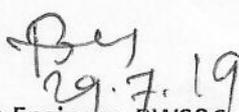

TERM & CONDITIONS FOR HIRING OF VEHICLES

The following terms and conditions must be fulfilled by the successful bidder for providing a vehicle on hire on monthly basis.

1. The hired vehicle during period of contract , shall have all necessary valid MV document such as valid Registration certificate, Insurance Certificate, Fitness Certificate,, Valid Contract Carriage permit, Up to date road tax payment etc. and D.L. of the driver available all the times. The department/office hiring the vehicle shall not be responsible for any damage/loss caused to hired vehicles or loss of life/injury made to any person or damage to any property on account of use of hired vehicle any manner what so ever. The hirer shall be responsible for all such litigation.
2. The hire charges to be paid for monthly basis are final. But does not include cost of diesel which is to be paid separately basing on actual consumption and lubricants as per existing government norms. All the expenditure of the vehicle towards repair, replacement of spare parts, Gear box and different coolant, tires, battery etc. will be borne by the bidders.
3. It shall be the responsibility of the bidder to provide a good driver and the salary of the driver shall be borne by the owner.
4. in case of the breakdown for reasons whatever the replacement of a vehicle of the same or better model shall be provided by the owner of the vehicle/bidder.
5. In case of the vehicle do not report regularly, the authority will be at the liberty to reject the agreement and may engage vehicle from other source.
6. The vehicle shall report for duty for minimum of 25 days in a month and as per need of the organisation.
7. In case of emergency, the driver will have to report for duty as per the requirement of hirer. No extra payment shall be demanded.
8. Monthly hire charges and reimbursement towards cost of diesel (as per actual) and lubricants (as per govt. norms) of sealed bidder will be paid in every succeeding month as per as possible within fifteen days of the submission of bills by the service provider and no advance payment will be made.
9. The vehicle shall not be more than 3 years old from the initial registration and also in good running condition during the contract of period.
10. If the services are found to be unsatisfactory, the client shall give one month notice and terminate the agreement.
11. In case the service provider intends to withdraw the service of his vehicle and terminate the agreement. It shall be mandatory upon him to grant one month notice before such withdrawal of service and termination of agreement.
12. If the bidder violates any of the terms of contract, the undersigned shall forfeit the entire amount of security deposit.
