If the office happened to be closed on the date of receipt /opening of the bids as specified, the bids will be received /opened on the next working day at the same time and venue.

Bid documents can be purchased from this office against a non refundable fee towards the cost of the document as indicated in the form of cash or demand draft issued from scheduled bank payable at SBI Kantamal as per DTCN in favour of the Block Development Officer, Kantamal, may be deposited in shape of bank draft prepared on or before the last date of receipt along with the bid.
6. Additional performance security shall be obtained from the bidder when the bid amount is less than the estimated cost put to tender. In such an event, the bidders who have quoted less bid price/rates than the estimated cost put to tender shall have to furnish the exact amount of differential cost i.e estimated cost put to tender minus the quoted amount as Additional Performance Security in shape of demand draft/ Team Deposit Receipt pledged in favour of the Block Development Officer, Kantamal in the sealed envelope along with the price bid at the time of submission of bids.


