

Sealed quotation /tenders are invited from interest reputed Travel Agencies/Tour Operators or private individuals for providing one no. of Diesel driven Non AC/ AC Diesel driven vehicle (Bolero/ Marshal/ Tata Sumo/ Mahindra Max) having sitting capacity not more than ten including driver, which shall conform to the Terms and Condition (Annexure-II) for official use in **O/o Land Acquisition Zone Officer, Khurda Road Bolangir New BG Rail Link Project, Boudh** on monthly rent basis.

- 1) The vehicle must be in Road Worthy condition, shall not be more than 3 years old from the date of initial registration and must have valid Registration Certificate, insurance Certificate. Fitness Certificate, valid Contract Carriage permit, proof of up to date tax payment etc which are mandatory for plying of vehicle
- 2) The Driver of the vehicle must have a valid Driving Licence for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle. The Driver must be available in the office at any time of exigency.
- 3) The Driver should be well behaved, gentle and obtained in nature.
- 4) A sum of Rs.5000/-(Rupees five thousand) only shall be deposited by the intending bidders in shape of Account Payee Bank Draft drawn in favour of the **Land Acquisition Zone Officer, KRB New B.G Rail Link Project, Boudh** and submitted along with the tender as security deposit. After completion of tender process, the amount will be refunded to unsuccessful bidders.
- 5) The monthly rate of hire charge be quoted separately in the general bid information (excluding fuel and lubricants).
- 6) The vehicle must achieve a fuel efficiency of 10 kms per litre.
- 7) The details of the make and year of manufacture of the vehicle ,registration no. mileage (Kms covered per litre) and name of the Driver with Driving licence No, place of residence of the driver with documentary evidence and period of validity should be specially provided in the general bid information to be furnished with the Quotation/Tender(Annexure-III)
- 8) The Quotation completed in all respect should reach the undersigned on or before 22.01.2020 by 05.00 P.M and shall be opened on 24.01.2020 at 10.30 am in this office chamber of the LAZO, KRB New BG Rail Link Project, Boudh
- 9) The application form of Quotation /Tender containing General Bid information and Terms and conditions for Hiring of Vehicle etc. will be available with LAZO, KRB New BG Rail Link Project, Boudh on payment of Rs.100/- from **14.01.2020 to 22.01.2020**.
- 10) The undersigned reserves the right to cancel the entire bid process at any point of time without assigning any reason thereof.

TERMS AND CONDITIONS FOR HIRING OF VEHICLES

The following terms and condition must be fulfilled by the successful bidder for providing a vehicle on hire on monthly rent basis.

1. The hired vehicles during period of contract shall have necessary valid MV documents such as valid Registration Certificate, insurance Certificate, Fitness Certificate, valid Contract Carriage Permit, proof of up to date tax payment etc. and D.L of the driver available all the times .The Department/Office hiring the vehicle shall not be responsible for any damage /loss caused to hired vehicle or loss of life /injury made to any person or damage to any property on account of use of hired vehicle any manner whatsoever .The hirer shall be responsible for all such litigation.
2. The hire charges to be paid for monthly basis is final but does include cost of diesel, which is to be paid separately basing on actual consumption and lubricants as per existing Government norms. All the expenditure of the vehicle Engine, Gear Box and differential coolant, Types & Tubes.
3. It shall be responsibility of the bidder to provide a good driver and the salary of the driver shall be borne by the owner.
4. In case of breakdown for reason whatsoever the replacement of a vehicle of the same or better model shall be provided by the owner of the vehicle/bidder
5. In case of the vehicle do not report regularly, the authority will be at liberty to reject the agreement and may engage vehicle from other source.
6. The vehicles shall report for duty for minimum of 25 days in a month
7. In case of emergency, the driver will have to report for duty as per the requirement of hirer No. extra payment shall be demanded.
8. Monthly hire charges and reimbursements towards cost of diesel (as per actual) of selected bidder will be paid in every succeeding month, as far as possible within fifteen days of the submission of bills by the service provider and no advance payment will be made.
9. The vehicle shall not be more than 3 years old from the date of registration and also in good running condition during the period of contract.
10. If the services are found to be unsatisfactory, the client shall give one month notice and terminate the agreement.
11. In case the service provider intends to withdraw the services of this vehicle and terminate the agreement .if shall be mandatory upon him to grant one month notice before such withdrawal of service and termination of agreement.
12. If the bidder violate any of the terms of contract Government shall forfeit the entire amount of security deposit.
