ORDER

In order to contain spread of the pandemic COVID-19 and enforce the precautionary measures laid out by the Government of Odisha, following instructions/advisory are hereby issued for all organizations/ individuals/commercial establishments in Boudh District :

A.Instructions for Monday to Thursday till 09.08.2020:

1. All shops dealing in essential commodities like vegetables, fruits, milk, fish/meat/egg, grocery etc. and shops selling agricultural equipments/ fertilizers etc., building & construction materials shall be open from **07.00 AM to 02.00 PM**. Medicine Stores, Gas Agencies, Petrol Pumps, Health Diagnostic Centres can be open throughout the day. It will be the responsibility of Shop Owner to ensure social distancing/ use of Mask during sale/ purchase.
2. There shall be complete prohibition on movement of individuals and vehicles from **02.00 PM to 07.00 A.M**. In case of any violations, heavy fine shall be imposed along with seizure of vehicles or shops.

Exemption: Movement of individuals and vehicles engaged in essential activities /officers on duty/doctors and personnel of medical establishments / telecom services /electronic and print media/ water supply and sanitation are exempted.

3. All Government Offices will be open as per Official Working hours with less than **50% of staff strength**. Use of Online mode/ work from home should be promoted. There shall be complete restriction on entry of public to Government Offices unless any urgent requirement arises or called upon by the Head of the Office. All Entry & Exit Gates of all Offices should be closed after entry of Officers/ Staffs.
4. Banks/ Insurance Companies/ CSC/ banking Kiosks will be open throughout the day for facilitating works related to farmers insurance primarily.
5. Hotels, Restaurants preparing lunch & dinner (no breakfast/ snacks) can only provide Take Away/Home Delivery Orders from **07.00 AM to 08.00 PM** only.
6. Dhabas/ Garages/ Auto spare parts shops along National Highways can be open. All Dhabas can only provide parcels/ take away.

7. Agricultural activities are permitted, farmers can go to their fields and travel only for purchase of agricultural equipments/ fertilizers etc.

B.Instructions for Friday to Sunday till 09.08.2020:


1. All shops & Commercial Establishments shall be closed completely. However, Medicine Stores, Gas Agencies, Petrol Pumps, Diagnostic Centres, shops dealing in agricultural equipments/ fertilisers can be open throughout the day. It will be the responsibility of Shop Owner to ensure social distancing/ use of Mask during sale/ purchase.
2. There shall be complete prohibition on movement of individuals and vehicles during this period of 3 days entirely. Complete Shut down shall be in place for this period. In case of any violations, heavy fine shall be imposed along with seizure of vehicles or shops.

Exemption: Movement of individuals and vehicles engaged in essential activities /officers on duty/doctors and personnel of medical establishments / telecom services /electronic and print media/ water supply and sanitation are exempted.

3. All Government Offices except Health Institutions/ Fire Stations/ Police Stations/ Tahasil & RI Offices/ Block Offices/ NAC Office, Boudhgarh/ Agriculture, Horticulture Office/ Offices dealing in supply of electricity, telecom service, Water & sanitation service will be closed. There shall be complete restriction on entry of public to Government Offices unless any urgent requirement arises or called upon by the Head of the Office. All Entry & Exit Gates of all Offices should be closed after entry of Officers/ Staffs.
4. Banks/ Insurance Companies/ CSC/ banking Kiosks will be closed during this period.
5. Hotels & Restaurants will remain closed during this period.
6. Dhabas/ Garages/ Auto spare parts shops along National Highways can be open. All Dhabas can only provide parcels/ take away.
7. Agricultural activities are permitted, farmers can go to their fields and travel only for purchase of agricultural equipments/ fertilizers etc.

Above Instructions are applicable to the entire district i.e. both rural & urban areas and shall be effective till 09.08.2020. No Government employee/ Private Sector employee can leave this district during the shut down period without prior permission of the undersigned.

All Incident Commanders/Executive Magistrates and other officers earlier authorised for enforcement activities must ensure strict implementation of above measures. Any person/organisation violating these measures will be liable to be proceeded against as per provisions of the Disaster Management Act, 2005 besides legal action u/s 188 of I.P.C.
