ORDER

In pursuance of Order No. 4582 Dt. 31.07.2020 of the Govt of Odisha in Revenue & Disaster Management Department (DM), Odisha, Bhubaneswar and partial modification of this office order no. 5788/Judl. Dated 07.08.2020, following relaxations are hereby notified to encourage economic activities during the COVID-19 lockdown:

<u>INSTRUCTIONS FOR THE PERIOD FROM DT. 17.08.2020 UNTIL FURTHER ORDERS:</u>

- 1. All categories of shops and commercial establishments can be open from 07.00 AM to 07.00 PM with following restrictions:
 - a. Gymnasiums, Swimming Pools, Bars will remain closed entirely.
 - b. Spitting/Chewing gum, gutka, tobacco in public places is strictly prohibited.
 - c. Restaurants/ Hotels/Fast Food/Street Vendors (Thela) can only give parcel and take away orders. Eating in the restaurants or near Thelas is strictly prohibited. Restaurants and Hotels can be open from 07.00 AM to 08.00 PM.
 - d. Dhabas along N.H/Garages/Auto Spare Parts can be open and are allowed take aways only.
 - e. Medicine Stores/Petrol Pumps can be open (24 X 7) through out the day.
 - f. Banks/Post Offices/Insurance Companies/CSCs/Banking Kiosks can be open as per normal operating hours.
 - g. Hotels and lodges are allowed to provide rooms to travellers, tourists. However, they should provide the daily data on details of the persons staying to the local police station.
- 2. There shall be complete restriction on movement of individuals and vehicles between 07.00 PM to 07.00 AM except for those on COVID-19 duty/ emergency services like Water, Electricity, Telecom, Sanitation etc. and Media Correspondents.
- 3. Congregation of more than 5 persons at a time in any place is strictly prohibited.

All other instructions contained in the previous order no. 5788/Judl. Dated 07.08.2020 shall remain the same. It shall be the responsibility of the shop owners to ensure Social Distancing, use of masks and sanitizer during sale/purchase. Any individual/ establishment or shop violating these will be subject to seizure/ seal besides imposition of heavy fines.

All Executive Magistrates and Authorised Officers are directed to conduct regular enforcement to ensure adherence to the above instructions in co-ordination with the Police. Any individual/organisation violating the instructions shall be proceeded against under Section 51 to 60 of the Disaster Managment Act, 2005 besides legal action under Section 188 of IPC.
