Sub: Bi-monthly FPS Dealer-wise allocation of food grains (Rice & Whole Chana) for families under the State Food Security Scheme (SFSS) for the month of September-2020 & October-2020.

Ref: FS & CW Department allotment Order No. 13198, Dated 11th September 2020

Madam / Sir,

With reference to the subject cited above, the allotment order of Rice & Whole Chana under State Food Security Scheme (SFSS) for the month of September-2020 & October-2020 issued by FS & CW Department, Odisha, Bhubaneswar, is hereby re-allotted for necessary distribution. A stock of Q. 1401.00 of rice and Q. 86.68 of whole chana for the month of September-2020 & October-2020 from Central Pool is to be distributed among the eligible beneficiaries under the State Food Security Scheme (SFSS) as per enclosed statement.

The scale of distribution of additional rice under State Food Security Scheme (SFSS) is 05 Kgs per person per month and 1 kg of whole chana per family per month on free of cost.

The above allotted PDS stocks should be released on to those Fair Price Shops (FPSs) which have valid FPS license / renewal for the Financial Year 2020-21 (till March-2021). Lifting and distribution of above allotted PDS should be started as per the timeline fixed in the table.

Distribution of Rice and Wheat at FPS point should be made only through e-PoS Devices without bio-metric scanning through finger prints/IRIS scanner wherever PoS device has been delivered to the FPS. Sales through manual mode should be discouraged as far as practicable. However, in case of any exigencies or in worst circumstances, such offline / manual mode of distribution should be resorted to only after due approval of concerned ADM, BDO/EO or CSO with proper justification. In such case, the distribution data must be synced to Odisha FPS server as and when network connectivity is available to e-PoS or by the last day of distribution.

Social distance must be maintained at the FPS Point during distribution of food grains and hand sanitizer, face mask shall also be used to prevent the spread of CORONA virus.


The following instructions must be followed strictly for ensuing meticulous distribution among eligible beneficiaries.

1. Per card entitlement of rice shall not be reduced below the prescribed allotment. Minimum 25 % verification of sale will be conducted by the Inspector of Supplies / ACSO in charge of the Block / ULB.
2. The distribution of foodgrains shall be under taken as per the dateline mentioned in the table above during which all the dealers will keep their shops open and keep sufficient stock for the consumers.
3. Certificate of GPLAC or WLAC will be obtained on proper distribution of food grains every month and submitted to the BDO / Sub-Collector / ADM with counter signature of Inspector of Supplies / ACSO as per Annexure-1 of DSS Guideline.

You are requested to ensure distribution of food grains to the genuine Ration Card holders.






