A walk-in interview/counseling is scheduled to be held on 15.01.2021(Friday) for engagement of Allopathy Medical officers on contractual basis under Health & F.W. Department of Boudh District. The selected candidates shall be paid consolidated remuneration as admissible by Govt norms from time to time.

NO ORV ACT WILL BE APPLICABLE FOR FILLING UP OF ABOVE MEDICAL OFFICERS POSTS
ELIGIBLE CRITERIA:-

- 1) Nationality: - He /She must be a citizen of India.
- 2) Age limit: - (i) The age of the applicant should be maximum 70(seventy) years for applying for the post of Medical Officer on contractual basis subject to physical fitness.
(ii) Date of birth entered in the high school certificate or equivalent certificate issued by concerned board/council will only be accepted.
- 3) Marital Status: - If married, the candidates must not have more than one spouse living
Provided that, the Government may, If satisfied that such marriage is permissible under the personal law applicable to such candidates or there are other specific grounds for doing so, exempt any candidates from the operation of this rule.
- 4) Physical Fitness:-The candidates must be of good mental and Physical Health and free from any physical defects likely to make him incapable of discharging her/his normal duties in the service.
- 5) The candidates who are already working in Health or any other Department on contractual basis should submit "NO OBJECTION CERTIFICATE" from their current employer along with the application along with service experience certificate from their appointing authority.

METHOD OF SELECTION:-

- 1) The walk-in interview/counseling will be held on 15.01.2021(Friday) & the candidates need to register themselves between 10.30 A.M to 11.30 A.M.
- 2) The candidate who will register first, his/her name the interview /counseling serial number will come first. Accordingly, the list of candidates will be prepared in chronological order of registration.
- 3) Vacancy list of Medical Officers of this District (V1 & V0 area) will be prepared by this department.
- 4) This appointment will be made purely on contractual basis & the cost of the remuneration shall be met from the state Budget.
- 5) The engagement of all the above posts are purely contractual basis and may be terminated at any time without notice and without assigning any reason thereof.
- 6) Placement may be made as per counseling or/and as per the decision of the selection committee.
- 7) The place of posting may be changed in view of public service and as per the decision of the selection committee.
- 8) After the initial scrutinize of all the applications, a database and provisional merit list of all candidates will be prepared on same day.
- 9) Publication of list of data base of the candidates will be hosted in the notice board on same day.
- 10) If any candidates are found to have suppressed any material, information related to their appointment or furnished false information/documents, his/her case shall not be considered for the post applied for and in case already engaged on the basis of the said information/documents, his/her service shall be terminated forthwith without any notice if detected in future.
- 11) Candidates who have been disengaged previously on administrative ground such as disobedience/poor performance /misbehavior / criminal activity etc are not eligible to apply.
