- v) Any dispute arising out of above process shall be under the jurisdiction of the District & Session Court, Boudh.
- vi) The Authority i.e. the Collector, Boudh reserve the right to cancel /modify the above term & conditions and can reject any bid without assigning any reasons thereof, if necessary .

The articles should be delivered in this office within 7 days from the date of issue of supply order failing which EMD shall be forfeited. The Cost of materials should include transportation charges and all taxes. Quotation received after due date or in incomplete form shall be rejected.
