## TENDER CALL NOTICE

Accordingly the quotation should be filed keeping in mind the transportation and installation cost. The last date for receipt of tender bids is 01.04.2021 by 10.00 A.M. and the bids shall be opened sameday on 1.04.2021 at. 11 A. M. by the Purchase committee in Office Chamber of the ADM, Boudh in presence of the quotationer or their authorized agents. The tender bids can be sent by Regd. Post or submitted directly to the Gen & Misc. Section, Collectorate, Boudh.

### Term & condition

- i) All bids shall be evaluated both on qualitative and economic aspect.
- ii) GST Certificate, GST Return of 3 yrs & IT Return of previous 3 financial years to be provided .
- iii) The rate quoted should include all transportation cost, taxes and installation cost.
- iv) Copy of PAN Card to be provided.

- v) Any dispute arising out of above process shall be under the jurisdiction of the District & Sessions Court, Boudh.
- vi) The Authority i.e. the Collector, Boudh reserves the right to cancel /modify the above term & conditions and can reject any bid without assigning any reasons thereof, if necessary .

The articles should be delivered in this office within 3 days from the date of issue of supply order falling which order may be cancelled. Tender Bids received after due date or in incomplete form shall be rejected.
