
**QUOTATION CALL NOTICE**

**TERMS & CONDITIONS**


- 1) The vehicle should be in good and running condition having valid documents like Insurance, Tex permit, fitness certificate, valid Driving license of driver.

- 3) The vehicle must achieve a minimum fuel efficiency of 10KM per litter and the mobile (lubricant ) will be provided 1 litter for every completed 500 KM.
- 4) All maintenance charges of the vehicle including driver will be borne by the owner.
- 5) Vehicle should be available at any time and the driver should remain present with vehicle. The vehicle owner cannot use the vehicle for his/her personal work at any point of time.
- 6) The log book will be maintained by the driver who will obtain the signature of the Officer using the vehicle. He should produce it before the concerned officer authorized by the under signed every alternative day for signature/ counter signature.


