TENDER CALL NOTICE



1. The Block Development Officer, Boudh on behalf of the Governor of Orissa invites Percentage rate bid in single cover system for the works as detailed in the table, from the class of eligible contractors as mentioned in **Col.6 (Six)**, registered with the State Government and contractors of equivalent grade / Class registered with Central Government/ MES / Railway, to be eventually drawn up in PWD' P-1 form, for execution of Buildings composite work (**Composite work i.e. Civil Work, P.H Work and E.I. Works**). The proof of registration from the appropriate authority shall be enclosed along with the bid. If successful, the bidder who has not registered under State Government has to register under the State PWD Inappropriate class of eligibility before signing the agreement. Bidders may submit bids for any or all the following work.


2. Bid documents consisting of plans, specification, the schedule of quantities and the set of terms & conditions of contract and other necessary documents can be seen in the office of the Panchayat Samiti, Boudh during office hours every day except on Sunday & Public holidays till last date of sale and receipt of tender paper. Interested bidders may obtain further information at the same address.
3. As per Works Department, Govt. of Odisha Office Memorandum No. 5984/W dt. 27.04.2021, no Bid Security/ Earnest Money Deposit (EMD) has to be deposited and all participating bidders shall submit "**Bid Security Declaration**" as per Annexure-I. of Bid Document. **Non-submission of Bid Security Declaration (i.e. in lieu of EMD), the bid will not be considered and rejected**
4. The sale of the bid document shall start from dt. **18.11.2021** in the office of the **Block Development Officer, Boudh** during office hour. The cost of bid document as mentioned in **Col.5** has to be paid by each bidder in shape of demand draft drawn in favour of **Block Development Officer, Boudh payable at Boudh** from any nationalized Bank. This is non-refundable. Sale of bid document will be closed at **5.00 P.M.** on dt. **26.11.2021**. The bid document may also be downloaded from website-<http://www.boudh.nic.in> during this period. The intending tenderers downloading the tender document has to pay the cost of tender paper for each set **Rs.6,000/-** in shape of **demand draft payable at SBI, Boudh in favour of Block Development Officer, Boudh.**
5. Bids shall be received in the office of the Panchayat Samiti, Boudh, till dt. **02.12.2021** upto **5.00PM- through Registered Post/Speed Post**. The authority will not be held responsible for postal delay in the delivering of the documents or non-receipt of the same..
6. Bidders shall submit an original affidavit regarding the authenticity of their documents and E.M.D. along with their bids. Bids shall be accompanied with attested true copy of valid registration certificate, GSTIN and PAN card, otherwise his/ her bids shall be declared as non-responsive and thus liable for rejection. The original certificates of the lowest three bidders are to be produced before Executive Engineer, DRDA, Boudh for verification.
7. Bidders can submit **one tender paper** only. Submission of more than one tender paper by a bidder for particular work will be liable for rejection.
8. The bid will be opened at **11. 00 A.M.** on dt. **03.12.2021** in the office of the undersigned, In the presence of the bidders or their authorized representatives, who wish to attend. If the office happens to be closed on the last date of sale and receipt / opening of the bids as specified, the bid will be sold and received/opened on the next working day at the same time and venue.
9. As per the Office Memorandum No. 4559/W dt. 05.04.2021 of Works Department , Government of Odisha, If the rate quoted by a bidder is (i) **below 5% less** of tendered amount, No Additional Performance Security deposit required, (ii) **From 5% & above & below 10% then such a Bidder shall be deposited 50%** of (Difference between estimated cost put to tender & Bid Amount) as APS, (iii) **For 10% & above then such a bidder shall be deposited 150%** of (Difference between estimated cost put to tender and Bid Amount) as APS. But if more than one bid is quoted equal % (Decimal up to two numbers will be taken for all practical purposes) less than the estimated cost, the tender accepting authority will finalize the tender through a transparent lottery system, where all bidders/ their authorized representatives, the tender inviting authority/ his authorized representative and Accounts Officer of Block will remain present
10. Additional Performance Security in case of Abnormally Low Bids (ALBs) shall be obtained from the bidder when the bid amount is less than the estimated cost put to tender. In such an event, only the successful bidder who has quoted less bid price/ rates than the estimated cost put to tender shall have to furnish the exact amount of differential cost i.e. estimated cost put to tender minus the quoted amount as **Additional Performance Security(APS)** in shape of N.S.C /K.V.P./P O.T.D / Post Office Savings Pass Book / Deposit receipt of any Scheduled Bank (Valid minimum one year from the date of receipt) duly pledged in favour of **Block Development Officer, Boudh** within **7(seven) days of issue of letter of acceptance(LoA)** otherwise the bid shall be cancelled and the earnest money deposit/ bid security shall be forfeited. Further proceeding for blacklisting shall be initiated against the bidder. (vide **Office Memorandum No.14459/W dt. 20.09.2018 of Works Department, Government of Odisha**)
11. For Building and other Construction Workers Welfare Cess @ 1% (One Percentage) of the cost of construction shall be deducted from bills.

12. Other details can be seen in the bidding documents.
13. Checklist is to be duly filled in.
14. Engineer Contractor desires to avail the facility of exemption of E.M.D. is required to submit an affidavit to the effect that he/she has not yet availed the facility/participated in the tender for more than two works(excluding this work) during the current financial year. The name of work for which and the authority to which the tender is being submitted must be mentioned in the affidavit, failing which the tender will be rejected.
15. The ST/SC contractor desires to avail price preference are required to submit an affidavit.
16. Any corrigendum/addendum will be displayed in the website <http://boudh.nic.in> only. So that the bidders are requested to visit the above web site regularly for any changes, since it will not be published in the paper again.
17. Conditional tender will summarily be rejected.
18. The undersigned reserves the right to cancel/reject the tender/bid without assigning any reasons thereof.




