
**Final Notification showing division of Wards and Reservation of
Seats in the Boudhgarh Notified Area Council.**

NOTIFICATION

Whereas, the provisional notification in Form-XXII of the Odisha Municipal (Delimitation of Wards, Reservation of Seats and Conduct of Election) Rules, 1994 showing the division of the Boudhgarh Notified Area Council into Wards and Reservation of Seats as required under sub-section (3) of Section 12 of the Odisha Municipal Act, 1950 was published in the notification bearing No. 335 dated 13.01.2022 for the purpose of giving opportunity to the persons to file appeal, if aggrieved against the decision of division of wards and reservation of seats in the said council.

And, whereas, appeal filed before the Appellate Authority within fifteen days from the date of publication of the said provisional notification has been heard by him and passed orders on the said provisional notification which was communicated by the State Government in their Letter No. 1722/HUD dated 30.01.2022.

Now, therefore, in exercise of the powers conferred by sub-section (3) of Section 12 of the said Act, the District Magistrate, Boudh do hereby divide the area of the Boudhgarh Notified Area Council into 17 wards as specified in Column (2) of the Statement - I below with the description and boundaries of the said Wards against each in Columns (3) and (4), respectively, thereof for the purpose of ensuing election of councilors to the same and determine the Wards as specified in Column (2) of the statement- II below in which the seats reserved under Section 11 of the said Act shall be set assigned against each in Column (3) thereof.


