Also they may inspect the said ambulances to be disposed off in 'as is where is conditions' on any working day during office hours at the designated locations. The sealed re tender papers to be submitted to the CDM&PHO, Boudh on or before 25/02/22 by Regd post/Speed post up to 5.30 P.M and the same will be opened on dt. 28/02/22 at 4.00 P.M in DTU, Boudh.

The Bidder of his Authorized representative may remain present at the time of opening of the sealed Re tender as per the above schedule programme. **Annexure-2** will be submitted by the bidder to authorize his representative to attend the bidding process.

The authority reserves the right to accept or cancelled any or all re tenders without assigning any reason thereof.

**Terms & Condition for disposal of condemned EMAS Ambulances (108) through Re tender call Notice.**

1. Condemned Ambulances are to be disposed off as per the statement Annexed.
2. The participants may inspect the ambulances during the official working hours with permission from the CDM&PHO, Boudh/Medical Superintendent CHC.
3. Ambulances will be auctioned in "as is where is basis".
4. Any liabilities if any of the said vehicle will borne by the successful bidder.

**RE TENDER FORMS :-**

- The terms, conditions and guidelines for Bidders should not be submitted with the RE TENDER FORM. Only filled up the re tender from should be submitted.
- Re tender shall be submitted in " RE TENDER FORM" **Annexure-1**
- Any mistake noticed in the Re tender Form will be decided by the Re tender screening committee and its decision will be final.
- The bidders shall quote the rate visibly in words (Block letters & Numerical) to avoid confusion.
- The Re tender paper shall be submitted in sealed cover with superscribed on the top of the envelope "**RE TENDER FOR DISPOSAL OF CONDEMNED AMBULANCES (108) bearing Regd. No.**\_\_\_\_\_". Also mentoring detail address on the left side of the cover with their Telephone No/Mobile no. etc.
- All Bidders shall submit the Re tender by Register post/Speed post only.
- Re tender will be opened on the stipulated Date & time by the constituted Re tender screening committee comprising of the following district level officers.

A. Re tender Paper Cost : Rs. 1,000 / (Rupees One thousand only)- per re tender per ambulance shall be deposited in favour of CDM&PHO, Boudh in shape of bank draft from any nationalize bank.

**B. EARNEST MONEY :-**

- The Earnest Money (Enclosed in Annexure - 3) for each ambulances will be treated as EMD and the same will be submitted along with Re tender Form. This will be drawn in favour of CDM&PHO, Boudh from any nationalize bank payable at Boudh.
- To facilitate immediate refund EMD the bidder should submit separate Bank Draft for each ambulances they have re tendered. The EMD of second highest bidder shall not be refunded until the successful bidder deposit the full amount and Re tender is finally decided in his favour.
- EMD of Unsuccessful Bidder will be refunded after finalization of Re tender and within 30 days no interest will be claimed by the Bidder.
- Where a Bidder has submitted one Bank Draft covering more than one vehicle and if there is highest offer in respect of any vehicle the bank Draft will be retained till Final decision of the conducting Authority.
- Retention of EMD of the highest and second highest Bidder does not guarantee any decision in favour of the Re tenders. Decision of the conducting officer shall be final.
- The Bidder quoting the highest price approved by the authority will be asked to deposit 25% of the Re tender value on the day of opening of Re tender by open announcement.
- ON failure to make final payment ( 75%), the aforesaid deposit of 25% including the EMD of the Bidder shall be forfeited and the vehicle put to fresh auction or re tender as the case may be.
- The Bidder should clearly mention their name & Designation, whether they may be Govt./Private organization.

**C. PAYMENT ETC :**

- On payment of total amount clearance will be issued by the CDM&PHO, Boudh
- No dispose-off value will be accepted without the presence of the successful bidder or their Authorized agents.
- The Condemned Ambulances will be handover to the successful bidder on receipt of full payment of the accepted Disposed-off value within 7 days of the approval of the offer.
- Tool Implements and spare parts shall not be delivered R.C Books etc which are not available shall not be delivered along with the ambulances.

- The successful bidder shall have to take the ambulances from the respective sites within 7 days of finalization of re tender process. Custody & safety of the disposed-off ambulances shall be responsibility of the successful bidder after it is finalized.

**D. GROUND RENT :**

- In case where the ambulance is not taken within the stipulated period ground rent @ 1% of the Auction value shall be charges for each day or part of the day till the vehicle is removed from the site.
- Where the ground rent to so charges exceeds the sale price deposited by the Re tenderer then he is ceased to have any right on the vehicle. The amount deposited by him shall be adjusted towards the ground rent & the vehicle shall become absolute property of Governments & free from encumbrances & may be deposed by fresh re tender or as per decision of conducting Authority.

**E. DISQUALIFICATION :**

- A Re tender may be summarily rejected by the Screening committee for the following reasons.
- Re tender not submitted on the prescribed Re tender Form
- Re tender received beyond the last date & time as stipulated.
- Re tender not submitted in sealed cover.
- EMD failing short of stipulated amount or without EMD.
- Sealed Re tender paper of any of the absentee Re tenderer may not be opened & returned to them with seal intact within 30 days.

**F. CORESPONDENCE:**

All correspondence including the legal complication on the Re tender and disposal of the Ambulances/Vehicles are to be complied by the concerned CDM&PHO, Boudh.

**G. AUTHORITY :**

- The authority reserves the right to accept or cancel any re tender or all re tenders without assigning any reason thereof & may settle the auction with the highest bidder on negotiation.
- In case of dispute or any matter the interpretation & discussion of the authority shall be final & binding and the legal procedures if any should be in the jurisdiction of Boudh.
