Online Registration for Admission to Class I in Kendriya Vidyalayas for the Academic Year 2022-23 will commence at 10:00 am on 28.02.2022 and will close at 07:00 pm on 21.03.2022. The Admission details are available in website <https://kvsonlineadmission.kvs.gov.in> and Android Mobile App. Minimum age for admission in class-I will be 6 years as per NEP 2020.

Parents are requested to go through the instructions for using the portal and mobile app carefully before using them. Registration for Class II and above will be done from 08.04.2022 (Friday) to 16.04.2022 (Saturday) upto 04:00 pm if vacancies exist (in offline mode).

Reckoning of age for all Classes shall be as on 31.03.2022. Reservation of seats will be as per KVS Admission Guideline available on the Website (<https://kvsangathan.nic.in>)
