





Terms and conditions of the Tender Notice for supply of Utensils for use of boarders residing in different ST & SC Hostels of Boudh District Functioning under SC & ST Development Department.

1. Sealed Tenders with samples are invited from intending registered firms/suppliers for supply of utensils for use in different ST & SC Hostels of Boudh District functioning under SC & ST Development Department.
2. The sealed Tender will be received by the District Welfare Officer, Boudh till AM/PM on \_\_\_\_\_ and will be opened before the District Tender Committee in the presence of the Tenderers or their authorized representatives at \_\_\_\_\_ AM/PM on \_\_\_\_\_. The Tenderers shall place their samples before the Tender Committee for verification during opening of Tenders.
3. The successful Tenderer shall be required to supply the utensils to the delivery points i.e. each ST & SC School points with free of cost as per the direction of the District Office Within specified time.
4. The Tender paper should be filled in properly and legible without any correction/overwriting and must be in typed copy. The rates and unit should be written both in figures and words in the Tender Paper. The rate quoted shall be final and the tenderer shall not be allowed to change the same under any circumstances and it should be valid until further orders.
5. Earnest Money Deposit of Rs.5000/- (Rupees five thousand) only shall be furnished along with the Tender Paper in shape of Bank Draft duly pledged in favour of the District Welfare Officer, Boudh. Tenders without Earnest Money Deposit will be liable for rejection. No Tenderer shall be allowed to withdraw his Earnest Money Deposit until the Tender is finalized. In case the successful Tenderer refuse to supply the utensils after acceptance of his Tender the EMD will be forfeited.
6. The Earnest Money Deposit of the successful Tenderer will stand converted to Security. Deposit which will be refunded after successful completion of the contract period and audit of accounts of the Supplier. The whole or part of the Security Deposit will be forfeited for irregular supply and not in accordance with the samples or breach of any terms and conditions during the period of contract. The Earnest Money of the unsuccessful Tenderers shall be refunded after finalization of Tender.
7. Xerox copies of Income Tax clearance certificate and Sales Tax clearance certificate/Valid GST clearance certificate in support of the payment of IT, ST at the prescribed rate in the beginning and at the end of every financial year and income tax PAN card copy shall be furnished along with the Tender.

8. Xerox copy of the Registration of the Firm/Dealership shall also be furnished along with the Tender.
9. The Collector, Boudh may terminate the contract for violation of terms and conditions as laid down or for any other reason to be recorded in writing.
10. The Tender Committee will verify the quality of the stock in accordance with the samples.
11. In case of the disputes the Tender Committee shall cause an enquiry and take suitable action including debarment against the supplier.
12. Any dispute in this matter to be settled under the jurisdiction of Boudh District only.
13. The detailed Tender Paper (Terms and conditions) should be submitted with the Tender by the Tenderer as a token acceptance of the terms and conditions.
14. Payment will be made as per approved rate and no request will be entertained for enhancement of rate approved.
15. The transportation of the articles to the concerned School points of the Dist. will be bear by the Supplier.
16. The Collector, Boudh reserves all the right either to reject any or all tenders or cancel the entire process without assigning any reason thereof.
