
Consequent upon revision of price of PDS Kerosene Oil at delivery depot point of Indian Oil Corporation Ltd. At-Malimunda, Dist- Jharsuguda w.e.f. 01.12.2022, the purchase price of PDS Kerosene Oil has been decreased from Rs.73,488.75 to Rs.72,964.75 (Rs.524/- per KL) hence I Sri Satya Ranjan Sahoo, OAS (Special secretary) Collector & District Magistrate, Boudh in exercise of powers conferred upon as per Clause 2(d)9i) of "The Kerosene (restriction on use and Fixation of Ceiling Price) Order' 1993" do hereby fix the purchase price of PDS Kerosene Oil for different SKO Wholesaler points of Boudh district as per the details worked out in the **Annexure-I** appended to this notification in conformity with uniform rate of different charges allowed to SKO Wholesaler/ Retailers vide FS & CW Department Letter No.9563 dtd.26.06.2019 and Letter No.18442 dtd.03.12.2022.
