





ANNEXURE – I

ELIGIBILITY CRITERIA

The firm must be registered with respective authorities like GST, as per rules. Copy of Income Tax Return for the last three financial years, i.e. 2019-20, 2020-21 & 2021-22 must be submitted.

- i. The firm should be in existence for over 3 years in the trade with the **75" IPS Panel Resolution – 3840 X 216 (UHD)** (copy of proof must be attached). Firms having Income Tax Return for 3 years may also participate.
- ii. The office of the firm should be located in Odisha, so that immediate replacement of defective materials can be ensured.

GENERAL INSTRUCTIONS / TERMS AND CONDITIONS

3. Any pre-bid query on the matter may be submitted over mail to dpcboudhssa.osepa@nic.in by dated. 16.03.2023 and its necessary reply shall be furnished to the respective email by dated.17.03.2023 by the office of the undersigned positively.
4. All entries in the tender form should be legible and filled in clearly. No underwriting / overwriting is allowed. If the space provided for furnishing information is insufficient, a separate sheet duly signed by the authorized person may be submitted.
5. The successful Tenderer has to supply the **75" IPS Panel Resolution – 3840 X 216 (UHD)** to the office of DPC, Samagra Shiksha, Boudh inclusive of quoted price., transportation in good condition and inclusive of installation charges. No extra price for transportation and installation will be demanded by the selected firm.
