

- 1. The member should be a member of a WSHG having a valid mission shakti ID.**
- 2. They should have a group PAN card.**
- 3. The member and President/Secretary should submit their own Aadhar card.**
- 4. As per the prevailing guidelines the member should deposit security deposit amount of Rs. 20000/- (Refundable) before TPSODL authorities.**
- 5. The person should submit the photo copy of bank passbook of WSHG.**
- 6. She should be able to operate android device.**
