01. Eligibility Criteria:

The Organizations/ Institutions other than Government bodies shall be eligible for assistance under this scheme subject to fulfillment of the following criteria:

01. Should be registered either under the Societies Registration Act, 1860 or the Indian Trust Act, 1882 or Section 8 of the Companies Act, 2013 or any other appropriate Act as notified by the Government of Odisha from time to time.
02. Should be registered under Section 139A & 12AA of the Income Tax Act, 1961.
03. Should be registered under the NGO Darpan Portal of Government of India.
04. Should be registered under Rule 18B of Odisha Maintenance and Welfare of Parents and Senior Citizens (Amendment) Rules, 2019. Provided that if not registered shall also submit for such registration along with project application.
05. Should ordinarily have existed for a period of two years and have resources, facilities and experience for undertaking the programme.
06. Should not discriminate against any person or group of persons on the grounds of sex, religion, caste, creed or disability.
07. Should not have been blacklisted by any central or state Government agencies
