Odisha Livelihoods Mission (OLM)

Proceedings of the Review Meeting of DPMs, OLM held on 07.09.2023 from 3.00 PM to 6:30 PM through Virtual Mode

A review meeting on activities of Odisha Livelihoods Mission (OLM) was held on 7th September 2023 from 3.00 PM to 6:30 PM through virtual mode, chaired by State Mission Director-cum-CEO, OLM. The meeting was attended by District Project Managers (DPMs), Additional CEOs, Dy CEOs and SMMU officials. The list of participants is enclosed at- **Annexure-I**

At the outset, the State Mission Director welcomed the participants, shared the objectives of the review meeting and advised the officials to work diligently for achieving the planned activities during 2023-24, that would give a visibility at the State and National level.

The issues and concerns relating to different programmes were discussed in details and following decisions were taken:


1. Expenditure on National Rural Livelihood Mission (NRLM) & National Rural Economic Transformation Project (NRETP)

- i. Districts to expedite the expenditure against their annual plan and utilise 100% of the amount allocated to them through PFMS.
- ii. The DPMs of laggard district under (NRLM) having less than 20% of expenditure shall be called for explanation. The districts with less expenditure are **Boudh, Gajapati, Kendrapara, Balasore, Cuttack, Jagatsingpur, Sonepur, Angul, Rayagada, Baragarh, Jharsuguda, Puri, Nuapada, Sundergarh, Jajpur, and Bolangir.**
- iii. Similarly under NRETP the poor performing districts are **Nayagarh, Deogarh, Kandhamal, Mayurbhanja, Rayagada, Gajapati and Koraput.**
- iv. Dy. CEO(CF)-cum-Project Manager Finance (I/C) will upload expenditure status of NRLM and NRETP on every were in the OLM Directorate, WhatsApp group.

Action: Finance Section, SMMU

2. Institution Building & Capacity Building

- i. The State Mission Director-cum-CEO expressed his displeasure on the progress of PMAY-G household survey, all DPMs were instructed to complete the mapping and reporting to SMMU by 15th September 2023.
- ii. DPMs were instructed not to release IB fund to any GPLFs until further communication from SMMU. However, they are allowed to disburse Start- Up funds and performance incentives of the Community Support Staff (CSS).
- iii. It is observed that only 47 % (2.47 Lakh) SHGs have availed Revolving Funds (RFs) as per NRLM portal. DPMs to ensure the updating of SHG data in NRLM Portal



received RF from NRLM or other programmes/state schemes by 30th September 2023.

- iv. Only 41% (2.11 Lakh) SHGs have availed Community Investment Fund (CIF). DPMs shall ensure that all the SHGs must avail CIF for grounding of their economic activities.
- v. It is observed that **DMMUs are releasing funds** to SHGs/CLFs/ GPLFs without following the fund disbursement module of NRLM. In this regard all DPMs were instructed to **release fund to SHGs/CLFs/ GPLFs through fund disbursement module of NRLM portal only.**

Action: All DPMs, IBCB & MIS Section of SMMU

3. Farm Livelihoods


- i. The assessment of Farm Livelihoods Clusters must be completed before 15th September 2023. The **laggard district such as Kendrapara, Boudh, Cuttack, Dhenkanal, Bargarh, Koraput, Nabarangpur, Nuapada, Puri and Khurdha** to expedite the progress.
- ii. DPM of Khurdha, Puri, Rayagada, Nabarangpur, Gajapati and Koraput are instructed to submit the ICRISAT activity report monthly and as per the instructions communicated.
- iii. Districts are advised to share success stories, quality photographs and related documents with the state team.

Action: All DPMs and Farm Livelihood Section.

4. Non-Farm:]

- i. As per the decision taken, Mission Shakti Department will oversee the operation of institutional canteens. The remaining three models such as Kiosk, Food truck, and Catering Services will be managed under Food Service Cluster of NRETP.
- ii. DPMs are advised to complete identification and uploading of the details of SHGs/ members for getting support under PMFME as per AAP 2023-24. The poor performing districts less than state average (43%) such as Dhenkanal, Nabarangpur, Bolangir, Jharsuguda, Sambalpur, Kendrapara, Nuapada, Koraput, Boudh, Mayurbhanja, Kalahandi, Keonjhar, Sundargarh, Gajapati, Deogarh, Rayagada, Malkangiri and Puri shall take special initiatives to achieve the progress.
- iii. Non- Farm team of SMMU to facilitate with district team for enrolment of enterprise under Udyog Aadhaar.
- iv. All DPMs are advised to monitor and ensure uploading of enterprise details in NRLM portal. The poor performing districts such as Boudh, Jharsuguda, Nabarangpur, Ganjam, Dhenkanal, Sonapur, Rayagada, Puri, Nuapada, Mayurbhanja, Khordha, Jajpur, Cuttack and Bolangir shall expedite the uploading.

Action: All DPMs and Non-Farm, Section



5. Financial Inclusion :

- i. All districts were instructed to enrol the left out eligible SHG members under PMSBY & PMJJBY as per target.
- ii. All district to complete Financial Literacy Training for SHG Members as per plan and upload the training details in SAKSHAM app.
- iii. DPMs shall prioritize for on boarding of IIBF-certified SHG members as BC "Sakhis".

Action: All DPMs and FI Section

6. Monitoring Learning & Evaluation and Management Information System (MLE & MIS)

- i. The progress of CBOs (SHG/ CLF/ GPLF) profile through LokOS was reviewed, DPMs, BPMs, Block and District MIS officials were advised to monitor the follow-up activities after completion of training to MBKs and CRPs on LokOS.
- ii. It was agreed that all districts shall complete creation of user IDs for CRP-CMs and MBKs, assigning of CBOs (SHG/ CLF/ GPLF) to the IDs and updating / validating the existing CBOs latest by 20th September, 2023 through LokOS. The poor performing districts such as Mayurbhanj, Puri, Bargarh, Nabarangpur, Sonpur, Dhenkanal, Jagatsinghpur, Balasore, Koraput, Kalahandi, Sundergarh, Cuttack, Gajapati, Nuapada and Jajpur to take focus interventions to expedite the progress.
- iii. The State Mission Director-cum-CEO instructed all DPMs to complete the mapping of SHGs with concerned CLFs by 18th September, 2023. Dy. CEO (MLE & MIS) shall upload the daily progress in OLM Directorate WhatsApp group.


