- 1) Multi coloured Tin Sheet printing cost Rs.400/- (Rupees Four Hundred) only for one sheet (including tax and transportation)
- 2) Tin sheet size : 3ft*2.5ft.(7.54 sq. ft.)
- 3) Made out of Tin sheet of 0.20 mm thick as per I.S.1993/93
- 4) 5 times pre-printing chemical treatment
- 5) 4 times multi coloured printing
- 6) Transparent coating and Heat treatment at 2000 C after each operation
- 7) Punching holes of diameter not more than 2mm at each corner and at the midpoint of each size of sheet length 3ft are to be provided. All total of punching holes are to be provided in each sheet.

The EPM approved Firms/Agency submit the expression of interest along with valid documents should reach in sealed cover to the DSWO, Boudh on or before 9th November 2023 at 5.30 PM by Registered/Speed Post only. The Authority shall not be responsible for any kind of postal delay. The Expression of Interest sealed cover shall be opened on 10th November 2023 at 11.00 A.M by the Collector, Boudh/ the officer authorized by Collector in presence of the members of Expression of Interest Committee and the Firm/Agency or their authorized representatives. The Expression of Interest received beyond the scheduled date, time and incomplete documents shall not be taken in to consideration.


