Terms and conditions:

- 1. The engagement is purely temporary and terminable at any time by the undersigned.
- 2. The candidate shall submit the written undertaking in model form enclose prior to their joining in the post as per contractual engagement.
- 3. The post of GRS under MGNREGS is a contractual and the engagement is initially for period of One year, which can be extended on the basis of the satisfactory performance and recommendation by the concerned BDO.
- 4. The contract of the GRS may be renewed for another One year by the Collector-cum-DPC, MGNREGS, Boudh and so on.
- 5. The Collector-cum-DPC,MGNREGS,Boudh will execute an agreement with the GRS in non-judicial stamp paper issued engagement order.
- 6. If any fraudulent testimonial is detected in future or if he/she has been criminally prosecuted, the engagement shall be cancelled without notice and action as deem proper will be taken against him/her as per the provision of law.
- 7. An undertaking should be submitted by the candidate as per prescribed format given by PR&DW Deptt. Vide Letter No.6681/Dated.06.04.2018.
- 8. Collector-cum-DPC, MGNREGS, Boudh is the disciplinary authority of the GRS is competent to terminate the contract to and disengaged the GRS on the ground of violation the terms and conditions.
- 9. The post of GRS is transferable in nature within the District. The Collector-cum-DPC, MGNREGS, Boudh is the competent authority to transfer GRS from one GP to another within the District in view of exigencies of public service or consideration of genuine grievance or administrative ground.
- 10. The selected candidates who execute agreements should submit their joining letter before the Collector-cum-DPC, MGNREGS, Boudh within one month from the date of issued of Engagement
- 11. If a selected candidate does not join within the stipulated date, i.e. one month from the date of issue of engagement order his/her candidature will be rejected.
- 12. The GRS will work in assigned GP under the administrative control of Block Development Officers of Boudh District.
- 13. They are allowed to draw their remuneration from respective Block with effect from the date of joining in Zilla Parishad, Boudh.
- 14. They shall perform their duty as per the guidelines issued under MGNREGS.

15. All terms and conditions subject to change as per guidelines issued by the Govt.from time to time.
