

GENERAL INSTRUCTION TO BIDDER

1. The bidder is required to submit a Bank Draft / DD worth Rs. 1000/- (Rupees One thousand) only in favour of the District Child Protection Officer (DCPO), DCPU at SBI Bank, Boudh towards the cost of Tender paper cost.
2. The unsuccessful bidder will get refund back the EMD cost after finalization of Bid and the successful bidder will get refund of his/her EMD after completion of work.
3. The tenders without EMD will be liable for rejection.
4. The organization should have PAN, valid GST number and up to date GST clearance certificate. Attested copies of PAN, valid GST number and GST clearance certificate should be attached.
5. The tender must not be blacklisted by any Govt. organization. (Attach declaration in Stamp Paper of Rupees Ten).
6. Rate should be quoted inclusive all taxes as applicable along with flex, iron frame cost and transporting charges. The defective and damage flex must be reattached by the organization.
7. The successful bidders have to complete flex banner display work at all prominent of the district within 15 days from the date of issue of work order from the DCPU.
8. The Tender paper should be filled in properly and eligibly without any correction / overwriting. The rate per Square feet should be written both in figures and words in the Quotation Form i.e. Financial Bid (placed at **Annexure-B**).
9. If the delivery is not made as per the stipulate time period the authority will be made penalty of the total cost.
10. Payment shall be made after successful delivery of goods with satisfactory condition after verification.
