1	The intending Registered Agencies should be a bonafied registered body having valid registration Number
2	The Organisation should be a valid PAN/TIN holder having valid GST Registration and Number
3	It should not be a black listed organisation by any Govt. Organisation
4	Rates should be quoted inclusive of GST charges ,other charges including printing cost, delivery charges, Installation charges etc.
5	The district administration will have no liability regarding transportation, loading and unloading of materials indent for supply & installation to the designated place in good conditions. The defective or damaged printing materials if any will be replaced by the organisation.
6.	The tender must be accompanied Bank Draft of Rs.2000/- (Rupees Two thousand) only in favour of DSWO, Boudh payable at Boudh towards tender paper cost.
7	The tender must be accompanied with Earnest money of Rs.15,000/- (Rupees Fifteen thousand) only in shape of Demand Draft in favour of DSWO, Bough. Tender without Earnest money will be liable for rejection. The EMD of unsuccessful bidder will be returned without interest on finalisation of bid. 

# MAMATA BOARD WITH FRAME SPECIFICATION




The angle used shall be of Tata/ Jindal make , the structure shall be installed with cement grouting for long life. The boards shall be riveted on the frame.


