
QUOTATION CALL NOTICE

- 3) The vehicle must achieve a minimum fuel efficiency of 10 KM per litter for Mahindra Bolero/ TUV300/Scorpio and 17 KM per liter for Swift Dezire /Celerio., Mobil (lubricant) will be provided 1 litter for every completed 500 KM.
- 4) All maintenance charges of the vehicle including driver will be borne by the owner.

- 9) The date of purchasing of Vehicle should be within 04 years as on the date of this notification . Preference will be given to new vehicle.


