
EXPRESSION OF INTEREST(EoI)

Terms & Conditions:


1. If the quoted price of more than one bidders/firm found to be equal, the committee reserves the right to take the final decision on it.

8. The undersigned reserves the right to accept or reject any or all the quotation(s), without assigning any reason thereof.






