

## **Tender Call Notice**

Sealed Tenders are invited in Plain paper from the intending persons for sale of the confiscated vehicle 12 Nos. of the description on "as is where is basis". The earnest money deposit for vehicle is mentioned against each in the list furnished below. The sale amount should be deposited in the shape of demand draft in the favour of the Divisional Forest Officer, Boudh Forest Division payable at SBI, Boudh main Branch. The tender paper will be received from Dt. 05.10.2024 during Office hour up to 1.00 P.M. of 09.10.2024 in the Office of the undersigned. The tenderers may submit the tender by Regd. Post or in Person. The tenders will be opened on the same day i.e. 09.10.2024 at 5.00 P.M. in presence of the tenderers or their authorized representatives with electoral photo identity card. The successful tenderers shall have to deposit 25% of the quoted amount and full tax amount under VAT @ 5% or as per the rule in force immediately after the announcement of the tender result and the rest amount within 7 days from the date of ratification of the sale and in case of unsuccessful tenderers the EMD will be refunded soon after the declaration of the result. In the case of default in payment of highest tender amount by the successful tenderers within the stipulated period the EMD and deposited amount shall be forfeited to Government and the vehicle will be put to fresh tender sale. The clearance of road tax etc. shall be responsibility of the successful tenderers. The undersigned reserves the right to either accept or reject any tender without assigning any reason thereof. The intending tenderers should inspect the vehicles lying in different places as noted below during office hours before submitting tender papers and no complaint shall be entertained after the tender sale is completed. Once the sale is ratified in the name of the highest tenderer all the liabilities, if any will be of the tenderers and no claim for any papers which are not available in this office will be entertained. Once the tenderers file the tender paper, it will be presumed that he has already fully satisfied himself about the present condition of the vehicle, liabilities or availability of the relevant paper of the said vehicle. The undersigned is not bound to accept the highest tender and reserves the absolute right to accept any tender or reject any or all the tenders without assigning any reason thereof. The intending tenderers are required to submit copy of voter identity card or any other authentic identity for their identification along with the tender papers. The successful tenderers shall remove the vehicle from the site within seven days from the date of depositing the full tender amount, failing which ground rent at the rate 1% of tender money shall be charged for each day or part of the day till removal of the vehicle from the site. Custody or safeguard of the vehicle shall be the responsibility of the tenderers and no claim or complaint on that account shall be admissible. Where the ground rent so charged exceeds the sale price deposited; the tenderer

shall cease to have any right on the vehicle. The amount deposited by him shall be adjusted towards the ground rent and the vehicles shall become absolute property of Government free from all encumbrances and will be deposed off by fresh sealed tender as the case may be.
