**Tender Call Notice**

**Notification No- 10760 /Dt. 04.11.2024**

1. Sealed tenders are invited for the sale **11nos** of confiscated vehicle from the Boudh Forest Division, available for purchase at the Boudh Forest Division. The vehicles are sold on an “as is, where is” basis, and no complaints about their condition will be accepted afterward.
2. Tender papers will be accepted from 05.11.2024 to 17.11.2024, on any working days between 11.00 A.M. to 5.00 P.M. at the office of the undersigned through obtaining the sale list and tender forms by paying Rs. 100/- (Rupees One Hundred Only) in cash for each set of documents which is non-refundable. Apart from that the Tenderers must submit a copy of valid government issue ID issue from Govt. of India or Odisha along with their tender papers either by registered post of by dropping them in a designated box. By submitting a tender, the tenderer acknowledges that they have thoroughly assessed the current condition of the vehicle as no complaints regarding the condition of the vehicles will be entertained on any circumstances after the tender sale is finalized. Tender papers will be opened on 19.11.2024 at. 4.30 P.M.
3. Intending tenderers must an Earnest Money Deposit for each vehicle, via **Bank Draft or Banker’s Cheque** payable to the **Divisional Forest Officer, Boudh Forest Division at SBI, Boudh main Branch**. Tenderers submitted without the required EMD will be rejected outright.
4. Tenderers may bid on multiple vehicles by submitting a separate tender form each vehicle, along with a distinct Bank Draft or Banker’s Cheque for the for the Earnest Money Deposit (EMD) for each submission. The EMD will be adjusted toward the sale value for successful bids and refunded within 7days after the completion of the sale event for unsuccessful bids.
5. The highest tenderer must deposit 50% of the accepted amount, including the EMD, via Bank Draft or Banker’s Cheque immediately, with the remaining 50% due within 10days of the ratification date.
6. If the successful tenderer fails to pay the quoted amount within the stipulated period of 10days after the ratification order, 50% of the tender amount, including the EMD, will be forfeited to the government. The vehicle will be re-offered through a new tender process. The vehicle will not be delivered until full payment and all formalities are completed.

7. The Divisional Forest Officer shall not handle any tax liabilities (Road Tax, Insurance and fitness charges etc.) as the bidder is solely responsible for preparing them.

8. Successful tenderers must remove vehicles from the site within 15 days of full payment. If this deadline is not met, a daily ground rent of 1% of the tender amount will be charged until removal. Tenderers are responsible for the custody and safe keeping of the vehicles.

9. The undersigned reserves the right to accept or reject any bids or cancel the invitation without reason. The decision of the Divisional Forest Officer, Boudh Forest Division is final and not subject to challenge, and the Officer will not be liable for any resulting consequences.
