Sub: **Revised-Tri-monthly FPS Dealer-wise Allotment order of food grains (Fortified Rice) for PHH and AAY families under NFSA, (Regular Allocation) for the month of October-November-December-2024.**

Ref: FS & CW Department Letter No. 17097, dt. 06.11.2024

Madam / Sir,

With reference to the subject cited above, the FPS wise Revised allotment order of Rice under NFSA-2013 for the month of **Oct-Nov-Dec-2024** issued by FS & CW Department, Odisha, Bhubaneswar, is hereby communicated for necessary distribution. A stock of **Q.63115.59 (Fortified rice)** for the month of **Oct-Nov-Dec-2024** is to be distributed among the Priority Households (PHH) and Antodaya Anna Yojana (AAY) households under NFSA (PMGKAY) as per enclosed statement.

**The Revised Instruction are as under**

1. The lifting and distribution of PHH wheat shall be stopped with immediate effect at (RRC-cum-DSC) and Fair Price Shops. The unlifted wheat at godwons and undistributed wheat at FPSs shall be kept under safe storage until further orders issued from the FS & CW Dept. for further utilization.
2. The un-lifted and un-distributed quantities of foodgrains entitlements (rice & wheat) in respect of blocks/ULB, FPS and Ration Card shall now be converted to 100% rice only.
3. The buffer management at SCMS application and database level iteration shall now be made 100% in place of 80% and 20% subject to ONORC (ration card portability) shall continue as such with necessary iteration in SCMS.


