- c. Size: 75" Flat Panel (4 GB RAM and 32 GB ROM with android -11)
- d. OPS: I5 12th Gen 8GB RAM and 256 GB SSD
- e. Security: 3 years company warranty and vendors free service.

2. Order for supply will be placed in bulk as per requirement, which is approximately 1 or 2-nos.

3. The quantity of aforesaid material may increase or decrease.

7. **Supply of Material:** The material is to be supplied within 15 days from the date of issue of work order, failing which the EMD & Security deposit will be forfeited and penalty @0. 5% per week subject to a maximum of 10% of the total Contract Value will be levied.

8. **Rate:** The rate quoted for all items should be inclusive of all taxes as applicable.

9. The cost of binding and Transportation Cost should be included in quoted price.

10. The Tax Deduction at Source (TDS) shall be done as per the provisions of Income Tax Act.

11. Quality of the material should be not compromise at any cost.

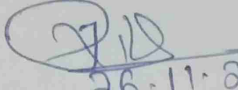
12. The bidder shall be held responsible for supply of materials as per the specification and any damage during the transportation.
