
TERMS AND CONDITIONS FOR PROCRUREMENT OF INTERACTIVE SMART PANEL BOARD

1. Specification of the Interactive Panel is as follows:-
 - a. Brand: LG/ SAMSUNG/ BENQ/ PANASONIC
 - b. Slider: Green Board & White Board
 - c. Size: 75" Flat Panel (4 GB RAM and 32 GB ROM with android -11)
 - d. OPS: I5 12th Gen 8GB RAM and 256 GB SSD
 - e. Security: 3 years company warranty and venders free service.
2. Order for supply will be placed in bulk as per requirement, which is approximately 1 or 2 nos.
3. The quantity of aforesaid material may increase or decrease.
