
Consequent upon revision of price of PDS S.K Oil at delivery depot point i.e Malimunda, Jharsuguda of Indian Oil Corporation Ltd. w.e.f 1.04.2025, the purchase price of S.K Oil has been decreased from **Rs.55528.75 to Rs.51178.75per KL (Rs.4350/- per KL)** hence I **Shri Subrat Kumar Panda, IAS**, Collector & District Magistrate, Boudh in exercise of powers conferred upon me as per Clause 2 (d)9(i) of "The Kerosene (Restriction on use and fixation of ceiling price) Order 1993", do hereby fix the selling price of kerosene Oil for retailers in different SKO wholesaler points of Boudh District as per the details worked out in the **Annexure-I** appended to this Notification in conformity with uniform rate of different charges allowed to kerosene oil Wholesaler / Retailer of the District vide F.S & C.W Department Letter No.6047 Dtd.03.04.2025. The closing balance stock of kerosene oil, if any, available with the SKO Wholesaler and retailers as on 31.03.2025 shall be issued at the price fixed for that month.
