NOTIFICATION

In exercise of the powers conferred by sub-section (3) and (3A) of Section 12 of the Odisha Municipal Act, 1950 (Odisha Act 23 of 1950) read with Sub-rule (1) of Rules 2A of the Odisha Municipal (Delimitation of Wards, Reservation of seats and Conduct of Election Rules, 1994, The District Magistrate, Boudh on his own motion (in case of new Municipality) / after consulting the Council of Boudhgarh Notified Area Council hereby gives notice that the Boudhgarh Notified Area Council in the District of Boudh shall be divided into 25 (Twenty Five) Wards as specified in column (2) of the Statement -I below with the description and boundaries of the said Wards against each in column (3) and (4) respectively thereof for the purpose of ensuing election of councilors to the same and the Wards as specified in column (2) of the Statement - II below in which the seats reserved under Section 11 of the said Act, shall be set assigned against each in Column (3) thereof.

Any objection or suggestion which may be received from any person interested in respect of the said draft notification on or before the date of expiry of the period of ten days (i.e. dt. 21.02.2026) from the date of publication of this notification (i.e. dt. 12.02.2026) will be considered. Objections or suggestions received after the said period (from dt. 12.02.2026 to dt. 21.02.2026) shall not be taken into consideration.


