**TERMS AND CONDITIONS FOR SUPPLY OF

BHARAT ABHIYAN FOR DISTRICT TUBERCULOSIS UNIT, BOUDH  
UNDER CDM & PHO, BOUDH (DISTRICT TB CENTRE, BOUDH)  
ON ANNUAL RATE CONTRACT BASIS.**

1. The bidders may download the tender documents directly from the [www.boudh.odisha.gov.in](http://www.boudh.odisha.gov.in). The bidders are required to submit tender document fee of Rs.1000/- (Rupees one thousand) only non-refundable, in shape of Demand Draft in favour of "District Tuberculosis Centre, Boudh" with tender documents.
2. The tender paper will be rejected if the bidder changes any clause or Annexure of the bid documents.
3. Sealed tenders will be received on / before date 22.06.2026 by 4 P.M. the CDM & PHO cum District Mission Director, Boudh in the office of the CDM & PHO, Boudh for Nutritional Food Basket items for on Treatment patients under PMTBMBA for DTC, Boudh etc. Any tender paper received after the due date and time will be rejected/returned to the sender unopened. The tender paper will be received through Speed Post/ Regd. Post/ Courier Only.
4. The CDM & PHO cum District Mission Director, Boudh shall have no responsibility for any delay / Omission on part of the bidder and reserves the right to reject any or all the tenders without assigning any reason thereof.
5. The bidder(s) are to submit their tenders in separate sealed covered envelopes for Technical Bid and Financial Bid by super scribing Cover 'A' (Technical Bid) and Cover 'B' (Financial Bid) & both the sealed covers should be put into a third outer cover which should be super scribed as "TENDER FOR SUPPLY OF NUTRITIONAL FOOD BASKET ITEMS FOR ON TREATMENT TUBERCULOSIS PATIENTS UNDER PMTBMBA FOR DISTRICT TUBERCULOSIS UNIT,BOUDH" and Tender Reference No. 2481 DTC / 2026 /NTEP/BOUDH/2026, Dt. 12.06.2026
6. The sealed tenders will be opened by the CDM & PHO, Boudh in the office chamber of the CDM & PHO, Boudh on dt. 23.06.2026 at 11 AM.The tender or their duly

authorized representatives are allowed to be present during the opening of the tenders if they so like.

7. The rate quoted by the bidder should be inclusive of all taxes (GST etc) & Transportation.

8. Conditional tenders are liable to be rejected. In the event of acceptance, decision of Purchase committee will be final. The tender which is not as per our required specifications will not be considered.

9. The authority will not make any advance payment to the organization. The organization will have to carry out the entire job on its own and the amount will be paid only after satisfactory completion of the job and submission of bill in that regards.

10. The supply of items shall be made immediately according to volume after placing the supply order in the office of the CDM & PHO cum District Mission Director, Boudh and supplier shall submit the bill for payment at the approved rate in respect to quantity of items supplied. The transportation of items is sole responsibility of the supplier and must deliver the item on door delivery basis as per required quantity issue supply order by the undersigned / ADPHO (TB) and supply at Superintendent of CHC Baunsuni, Manamunda, Adenigarh.

11. The items should be delivered within 10 days from the date of receipt of the purchase order.

12. In case of failure on the part of the approved supplier to supply of the above mentioned items as per supply order with stipulated period, the CDM & PHO, Boudh shall be at liberty to purchase above mentioned items from other sources and the approved supplier shall be liable to pay the excess amount which this office have to incur being the different of actual amount of purchase minus the amount as per approved rates and difference aforesaid shall be recoverable and adjustable against the EMD or any payment due.

13. Under no circumstances shall the organization appoint any sub contractor or sub lease the contract. If it is found that the organization has violated these conditions the contract will be terminated forthwith without any notice and EMD deposited by the organization shall be forfeited.

14. Rates quoted against this tender notice shall remain valid up to 12 months after award of contract or till next tender happening with ever earlier. No request of increase in rates, if any, will be allowed or entertained during this period.

15. If the successful bidder/ bidders fails to supply the entire quantity within the stipulated period or re fixed delivery period (as mentioned in Point 11), the buyer will be entitled to deduct or recover the for the delay , unless cover under force majeure conditions @ 0.5 % per week or part of the week of the week delayed or delayed period as per pre-estimated damages not exceeding 10% of the contract value without any controversy or dispute of any sort whatsoever.

16. Jurisdiction: All disputes are subject to the jurisdiction of Boudh courts only.

17. If any information/documents furnished by the tenderers with the tender papers are found to be misleading or incorrect at any stage there tenders will be cancelled.

18. The undersigned of committee reserve the full right to accept in full or part or reject any of all the tenders without assigning any reasons thereof without any liability to communicate any reason.

19. Tender must be accompanied by EMD of Rs.10,000/-Demand Draft (Ten thousand) by way of Demand Draft (Must be submitted), in favour of DISTRICT TUBERCULOSIS CENTRE,BOUDH, Payable at SBI BOUDH, Dist-Boudh. Tenders if not accompanied by EMD bid will not be considered. EMD of unsuccessful bidder will be returned without interest on finalization of bid. EMD of successful bidder will be retained & will be refunded on successful completion of the job without interest (Valid for 1 year).

20. Average Annual turnover of the bidder must be  $\geq 10$  Lakh in last three preceding financial year's .*Bidders claiming relaxation regarding turn over must submit valid documents in this regard. The Average Annual turnover should be submitted in the format attached in the Bid Document (FORM- T2).*

21. The Bidder is required to submit a Declaration in Twenty Rupees stamp paper that the bidder is not blacklisted by any institution. Format is attached (FORM-T3)

22. The Bidder is required to submit undertaking in the Letter Pad regarding the quoted rates are not more than the prevailing market prices.
